# Improving Awareness, Compliance and Audit Preparedness

Infinity Group UK wanted to deliver regular, monitored staff training that would both raise awareness of cyber risks and support compliance needs. As a managed service provider supporting a wide range of clients, Infinity Group UK also needed a solution that could be easily scaled and reported on across different industries, while still meeting its own internal compliance and audit requirements. Preparing for an ISO audit and training staff on GDPR were key drivers, alongside the need to gain a clearer understanding of the company's overall human cyber risk.

#### Specific goals included:

- Increasing staff awareness of cyber risks
- Delivering consistent compliance training on topics like GDPR
- Maintaining evidence of training and testing for ISO audit readiness
- Understanding the organisation's overall human cyber risk profile

#### The Solution

# usecure automates awareness, compliance and audit readiness

To address these needs, Infinity Group UK implemented usecure's Human Risk Management platform:

- Automated Security Awareness Training Staff completed 209 training courses with an average score of 91%.
- Phishing Simulations 513 phishing simulations delivered, with only 1% of attempts compromised, driving phishing resilience up to 99%.
- Risk Reporting Management gained real-time visibility into the company's human cyber risk, including detailed uPhish and overall company scores.
- Automation Training, simulations, and reporting processes were streamlined to save time and reduce manual administration.

#### The Results

### usecure Cuts Human Cyber Risk by 60% for Infinity Group

After launching targeted phishing simulations and awareness campaigns, Infinity Group UK saw rapid improvements:

- Over 60% reduction in overall Human Cyber Risk Score (from 565 to 223)
- 93% decrease in uPhish Risk Score (from 350 to 23)
- 99% phishing resilience (513 simulations, 1% compromised)
- 91% training average across 209 completed courses.

These improvements not only strengthened Infinity's internal security posture, but also reinforced confidence in their ability to protect client organisations — a critical responsibility for every MSP.

#### **How They Did It**

# usecure simplifies Infinity Group UK's training, simulations and risk reporting

Infinity Group UK used usecure's platform to deliver regular, monitored staff training and phishing simulations across the business. Employees engaged with security awareness courses, completing 209 modules with an average score of 91%, while phishing simulations tested their ability to spot real-world threats — resulting in only 1% of simulated attacks being compromised.

The automation features meant campaigns could be delivered consistently with minimal administrative effort, while reporting tools provided clear visibility of company-wide risk. This allowed Infinity Group UK to measure improvements over time and ensure that staff were continually strengthening their awareness of cyber risks. These initiatives contributed directly to a 93% reduction in uPhish risk scores and over a 60% decrease in the company's overall human cyber risk score.
